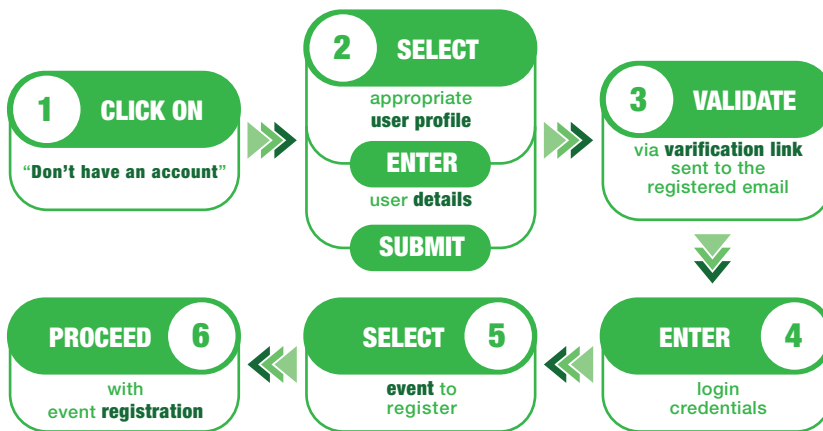

CONFERENCE FEE

- Fee is payable to **MALAYSIAN INSTITUTE OF ACCOUNTANTS**.
