AZIZAH MOHD GHANI

Azizah is Senior Manager from Professional Practices & Technical at MIA. PROFESSOR DR. CHRISTOPHE SCHINCKUS

Prof. Christophe Schinckus is professor of finance and Head of the School of Finance and Economics at Taylor's University in Malaysia. His research deals with physics applied to finance and FinTech. He has published over 100 papers in peer-reviewed journals and authored a book on Econophysics by the Oxford University Press. Prior to

Taylor's, Prof. Schinckus taught at: University of Quebec at Montreal, Canada; London School of Economics and the University of Leicester in the UK; and RMIT Melbourne, Australia. After his degree in Engineering, Prof. Schinckus continued his studies with a PhD in Finance at the University of Paris-Pantheon Sorbonne, France and a second PhD in Philosophy of Science at the University of Cambridge, UK. He is currently involved in his third PhD in Mathematical Physics at the University of Hertfordshire, UK. In parallel to his academic activities, Prof. Schinckus also collaborates as a research consultant for private companies, including JPMorgan, Suez Gaz de France etc. and he recently worked with the African Development Bank.



PROFESSOR EWE HONG TAT

Prof. Ewe is a Senior Professor at the Lee Kong Chian Faculty of Engineering and Science, and Vice President (Internationalisation and Academic Development) at Universiti Tunku Abdul Rahman. He is an Educational Counsellor and Regional Chair (Malaysia) of the MIT Educational Council; a Fellow and Secretary General of the ASEAN

Academy of Engineering and Technology; a Fellow of the Academy of Sciences Malaysia; and was a Council Member of Malaysia Qualifications Agency. He had previously worked with Motorola Penang, Intel Penang, MIT's Research Laboratory for Electronics, University of Malaya, and the Multimedia University where he served as Vice President (Academic). He is active in consultancy and technopreneur development works and has been a consultant/advisor for several listed and startup companies in Malaysia. Prof. Ewe holds a Bachelor's in Electrical Engineering (1st Class Hons) from University of Malaya; Master's in Electrical Engineering and Computer Science from M.I.T., USA; and a PhD from Multimedia University Malaysia. His research interest includes microwave remote sensing, satellite image processing, wireless sensor network and intelligent computing. He has published in books, international journals and conferences and newspapers. He has received a number of awards including The Young Scientist Award of URSI (International Union of Radio Science), The Outstanding Young Malaysian Award 2005 for Academic Leadership and Accomplishment, and The Toray Science and Technology Award by Malaysian Toray Science Foundation.


WAN RAIHANA WAN AASIM

PROGRAMME FEE

- Fee is payable to MALAYSIAN INSTITUTE OF ACCOUNTANTS
- Depending on the event, the fee includes course materials and/or lunch and/or tea breaks.
- Individual Registration: Full payment shall be made at the point of online registration.
- Corporate Registration: Full payment shall be made within thirty (30) days from the date of the Proforma Invoice or on the day of the event, whichever earlier.
- Admittance may be denied upon failure to make full payment as per the above requirement.

CANCELLATION
