#### FUTURE PROOFING THE FINANCE TALENT

Through the World Economic Forum's Future of Jobs Report 2020 estimation, by 2024, around 40% of the workforce will require reskilling of up to six months, and 94% of business leaders report that they expect employees to pick up new skills on the job—a sharp rise from 65% in 2018. Future finance professionals will require process management and exception management skills to administer digitally enabled processes, and digital finance experts and data scientists to analyse internal and external data to provide critical insights to the business.




## **DR ZUNIKA MOHAMED**
